The length of the attorney-client executive session is estimated to be approximately one hour.

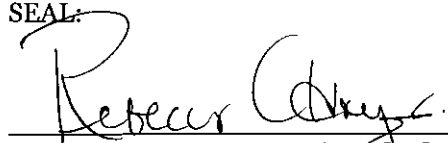
