Chair Hacker called the meeting to order at 3:00 PM.

Chair Hacker asked for typographical corrections to the Public Works Administration and Beaches and Coastal Facilities budget motions on pages 2 and 3 of the minutes.

- b. Fiscal Year 2020 Third Quarter Financial Report

Vince Tenaglia, Finance Director & Assistant City Manager, presented the findings of the third quarter Financial Report. He reviewed the overall budget status including fund levels and provided an update on revenue sources that are exceeding, on track, and being monitored at this time. He indicated that rental income for weddings, events and classes was down due to Covid-19.

General Fund Expenditures, Enterprise Funds and Capital Project Status, were reviewed. The Cash Balance/Treasury Report and Portfolio Allocations were reviewed and reported to be in good condition.

Mr. Tenaglia opened the meeting for questions and discussion. Following a brief discussion, Chair Hacker asked for any further comments. Hearing none she called for a motion to adjourn.
